

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AND PARENTAL CONSENT AGREEMENT

In consideration of being permitting to participate in a Summer Camp (“the Camp”) at Oxbow Farm & Conservation Center (“Oxbow”), I the undersigned, on behalf of

_____ (“the Participant”):

ACKNOWLEDGE, agree, and represent that I understand the nature of the Camp and that the Participant is in good health, and in proper physical condition to participate in the Camp.

FULLY UNDERSTAND THAT: (a) Participation in the Camp at Oxbow is voluntary, and involves risks and dangers of bodily injury *; (b) these Risks and dangers may be caused by the Participant’s own actions or inactions, the actions or inactions of others participating in the Camp, the condition in which the Activity takes place; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation or that of the participant in the Camp.

*Specific risks of the Camp include: proximity to working farm equipment, physical injury from active games, dehydration or heat exhaustion, insect bites, animal encounters, transportation on farm vehicles (as in hay rides), wasp or bee stings, cuts, scrapes, bruises and sprains while climbing/running/walking, reactions to foraged foods. Serious injuries are also possible, including broken bones, paralysis, drowning, or death.

AGREE TO ABIDE by all rules promulgated by Oxbow while the Participant, or Participant’s family member or guest, including any minors, are present in, observing, using, or participating in any Camp activities or while visiting the Camp facilities at Oxbow.

HEREBY RELEASE, HOLD HARMLESS Oxbow Farm & Conservation Center, their respective administrators, directors, members, volunteers, and employees, Camp Staff, other participants, or owners of premises on which the Camp takes place from all liability, claims, demands, losses, or damages on my account causes or alleged to be cause in whole or part by the negligence of Oxbow or otherwise, including negligent rescue or first aid operations. I further agree to WAIVE ALL CLAIMS against Oxbow and/or its representatives, including, but not

limited to, claims for property damage, personal injury, or death arising from or related to the enrollment of the Participant in Oxbow's programs and activities, made by anyone on my behalf or on the behalf of the Participant.

ASSUME FULL RESPONSIBILITY for any items lost, stolen, or damaged while myself, or the Participant is present in, observing, using or participating in the Camp.

ACCEPT FULL RESPONSIBILITY and liability for and indemnify Oxbow and its representatives against the cost of treatment, transportation, or any other costs incurred for the treatment of any injury suffered by the Participant, the Participant's family members, or guests while participating in activities or programs at Oxbow.

CONSENT TO THE TREATMENT, to include first aid and CPR, of the Participant by Camp Staff, as they deem appropriate.

GIVE PERMISSION for the Participant be transported by ambulance, treated by aid car personnel, and/or transported to an emergency medical center/hospital for treatment. I further authorize and consent to the medical, surgical, and hospital care, treatment, and procedures to be performed for the Participant by a licensed physician or hospital when deemed immediately necessary or advisable by the physician to safeguard the participant's health.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, AND UNDERSTAND that I have giving up substantial rights by signing it and release all liability to the greatest extent allowed by law. If any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
